

Honorable Order of the Blue Goose International Scholarship Program for the Texas Pond

Application Process

- 1. If applicant is a high school or current college student, submit the completed application along with college acceptance letter to an executive committee or scholarship committee member via sponsoring Gander no later than April 30th of the current calendar year.
- 2. If applicant is not a current college student, and is no longer in high school, a letter of acceptance from the college is required in addition to completed application.
- 3. Application Attachments:
 - a. A copy of the applicant's high school or college transcript(s),
 - b. A copy of the applicant's letter of acceptance (high school senior),
 - A copy, or other acceptable forms of documentation, of any relevant awards, recommendations, or documents that will assist in the award selection process for the committee;
 - d. Application essay (minimum of 500 words); and
 - e. One (1) personal reference/recommendation and two (2) academic references/recommendations originals, no photocopies.

Guideline Agreement

I understand that any money/aid/scholarship awarded to me will be paid directly to the accredited institution I have chosen to, and have been formally accepted to attend. I must be enrolled as a "full-time" student as defined by the college, junior/community college, university, or accredited trade school per semester/ quarter/term. The funds must be used within one (1) calendar year and I must maintain *passing grades* (2.5GPA minimum) in the first semester/quarter/term in order to receive the funds in the subsequent semester/quarter/term. This money/aid/scholarship will be used for tuition, books, fees, housing and other items directly related to the enrollment in the institution.

I understand that if I do not enroll, attend, and/or withdraw from the institution, any unused money will revert back to the Blue Goose Texas Pond Scholarship Fund.

I certify that all my responses and statements are true and factual. The decision of the selection committee is final and non-reviewable. By submitting this application and all required documents you understand and agree to all the terms and conditions contained herein.
